



Pension Benefit Approval Letters

The Office of Pensions will no longer send a copy of the pension benefit approval letter to organizations. Currently, when a pension application is completed, the End User receives an e-mail notification that the application is CLOSED.

Also, within Pen-App, there are additional ways to know when the pension application is completed.

First, navigate to **Pension > Pension Application > Application Page**. After entering the **CRIS EmplID** and clicking the **Search** button, the page will look like this:

Second, navigate to **Pension > Pension Application > Search**. Choose the **Application Status** of **Closed** and click the **Refresh** button.

Pension Application Reminders

- When the service for a Pension Application has been verified by the Office of Pensions, the End User receives an e-mail notification that the application is **ACCEPTED**.
- Click the **Print Application** button once the service has been **Accepted** and the employee has been contacted with an appointment to come in to sign the Pension Application and complete all other pension paperwork.
- Click the **Sign Form** button after the employee has signed the Pension Application and the packet is being sent to the Office of Pensions.
- Upon the termination of an employee who meets the eligibility requirements for a vested pension benefit, a Vested Pension Application should be submitted through Pen-App unless he/she is withdrawing their accumulated contributions plus interest. If the eligibility requirements for a vested pension benefit are not met, the employee should complete either a Contributions Retention Notice (CRN) or Withdrawal of Benefits (WB) form.
- State Employees' Pension Plan (SEPP) Only: Upon the termination of an employee due to the exhaustion of their Short Term Disability (STD) and upon their approval of Long Term Disability (LTD), a Vested LTD Pension Application should be submitted through Pen-App.
